FACTORIES AND MACHINERY ACT 1967

FACTORIES AND MACHINERY (STEAM BOILER AND UNFIRED PRESSURE VESSEL)  
(AMENDMENT) REGULATIONS 2014

IN exercise of the powers conferred by subsection 56(1) of the Factories and Machinery Act 1967 [*Act 139*], the Minister makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the **Factories and Machinery (Steam Boiler and Unfired Pressure Vessel) (Amendment) Regulations 2014**.

(2) These Regulations come into operation on 4 February 2014.

**Amendment of Fourth Schedule**

2. The Fourth Schedule of the Factories and Machinery (Steam Boiler and Unfired Pressure Vessel) Regulations 1970 [*P.U. (A) 5/1970*] is amended by inserting after item 40 the following item:

“41. Japan Inspection Co. Ltd., Tokyo.”
